SCHEDULE B

CONSTITUTION (Section C)

The purposes of the Society are:

- (a) to receive, hold, acquire and invest bequests, donations, gifts, funds and property and to administer and distribute funds, property, endowments, trusts and financial programs for funding and support of the programs and activities of the Powell River Salmon Society and any successors to the Powell River Salmon Society provided that such successors of the Powell River Salmon Society are qualified donees under the *Income Tax Act* (Canada);
- (b) if Powell River Salmon Society ceases to exist without a successor, then to receive, hold, acquire and invest bequests, donations, gifts, funds and property and to administer and distribute funds, property, endowments, trust and financial programs for funding and support of programs and activities that are similar to those which were operated by the Powell River Salmon Society and which are operated by qualified donees under the *Income Tax Act* (Canada); and
- (c) to do all such things as are incidental and ancillary to the attainment of the foregoing purposes and the exercise of the powers of the society.
